GRUFC 200 CLUB POLICY RULES & ORGANISATIONAL PROCEDURES

POLICY STATEMENT & PURPOSE

The 200 Club has been introduced by Glossop Rugby Union Football Club (“the **Club**”) for the purpose of obtaining funding for the Club. It is a private lottery open to members and friends of the Club.

Any money received from the 200 Club will be paid directly into a dedicated GRUFC 200 Club bank account. Any payments of prize money will be paid from this account and any funds left over after all prize monies have been paid, will be transferred to the main GRUFC account, at the discretion of the 200 club administrator and Club Treasurer, to be used in line with general club expenditure as voted under normal General Club Committee rules.

RULES & ORGANISATIONAL PROCEDURES

1. The 200 Club is open to anyone aged 16 and over;
2. Currently there are 200 available numbers in the draw but the General Club Committee reserves the right to amend the numbers available as per the Club’s requirements;
3. Numbers are not limited per household.
4. A number costs £2 per draw and once a Direct Debit form is processed; an available number will be allocated between 1 and 200;
5. There is one 200 Club draw per month and numbers are drawn by General Club Committee officials during the monthly committee meeting, or at an event where at least two committee officials are present. The 200 Club Administrator will never draw the numbers but may be in attendance at the draw;
6. A monthly draw will be made consisting of a 1st, 2nd and 3rd prize.
7. Currently, the prize money totals £100 per month, apportioned as: 1st prize of £60, 2nd prize of £25 and 3rd prize of £15. The General Club Committee reserve the right to amend the prize money at their discretion.
8. All payments must be made by Direct Debit and one full month’s notice is required for cancellation. If a member wishes to cancel half way through a month, they will be required to pay for their 200 Club numbers for that particular month;
9. Member’s numbers will only be entered in the draw if their subscription is up to date;
10. If a member has no valid reason for missing a payment, their number may be issued to someone on the reserve list.
11. The winners of the 200 Club draw will receive their prize money preferably by BACS transfer directly to the Bank Account nominated on their membership form no later than 4 weeks after the draw.

12. The name and numbers for each month's winners will be posted on the Club Facebook page and other social media as required, unless we are informed otherwise.
13. The 200 Club will be managed by the 200 Club Administrator and may be overseen by a General Club Committee Member within the club structure.
14. In case of any dispute the decision of the General Club Committee is final.
15. Unless otherwise advised, a member will be deemed to have withdrawn from the 200 Club if his/her subscription renewal remains unpaid for a period of two months. The member has no right to be informed of the withdrawal, but the club will endeavour to let the member know if possible.
16. If for some reason the winnings are unable to be paid into the registered Bank Account, or the prize money is uncollected and the participant is unable to be contacted within 3 months of winning, the money will remain as property of the Club and the member will have no entitlement to it;
17. The onus is on the 200 Club member to ensure all relevant contact details are up to date.
18. The General Club Committee reserve the right to amend the value of the prize money and members of the General Club Committee at their discretion.
